Vol. 148: READ Act Reauthorization, US-Nepal Child Protection Compact, & UN Child Rights Mainstreaming

September 5, 2023

Quick Summary

U.S. and Nepali officials have begun discussions on a Child Protection Compact (CPC) Partnership, aimed at tackling child sex trafficking and forced child labor in Nepal. This non-binding plan involves an initial investment of up to \$10 million from the U.S. to support anti-trafficking efforts through civil society and international organizations. The Partnership will build upon existing anti-trafficking efforts in Nepal, aiming to strengthen the country's ability to investigate and prosecute child trafficking cases, respond to forced child labor and child sex trafficking, provide comprehensive support to trafficking victims, and prevent future incidents. In response, to civil society activism to urge the UN Secretary-General to prioritize a child rights approach across all UN entities, the Secretary-General developed a "Guidance Note on Child Rights Mainstreaming" aimed at integrating children's rights within the UN's management, programs, and operations across development, human rights, and peace and security sectors. The document was crafted by a group including the Office of the High Commissioner for Human Rights (OHCHR), UNICEF, Special Representatives of the Secretary-General on Violence Against Children and Children in Armed Conflict. The Note encourages change and sets pathways for follow-up through various means, including a report on child rights mainstreaming by the High Commissioner for Human Rights to the Human Rights Council in March 2024 and oversight by a Task Team co-led by OHCHR and UNICEF. Civil society is advised to use the Note for change by advocating for a child-friendly version, promoting it within networks and UN entities, urging more resources for child rights within the UN, and utilizing its language for advocacy and engagement at various levels. The Note also emphasizes child participation and advocates are encouraged to push for inclusivity, sustained interaction with children, and development of a UN-wide policy framework on child participation and safeguarding. A recent <u>article</u> co-authored by Amitabh Kant, India's G20 Sherpa, and Helen Clark, Partnership for Maternal, Newborn & Child Health (PMNCH) Board Chair, emphasizes the urgent need for the G20 to address the health and wellbeing of women, children, and adolescents on a global scale. They highlight that nearly two million preventable deaths occur annually among these groups in G20 countries, with factors like COVID-19, conflict, climate change, and the cost of living crisis playing significant roles. The G20's collective actions hold immense global influence, making it crucial for them to act swiftly to improve the health of these vulnerable populations. The article emphasizes that the G20 must make the health and wellbeing of women, children, and adolescents a permanent agenda item, requiring sustained financing, global coordination, and solidarity to ensure no one is left behind. Act 2023 (H.R.681/S.41), which requires urgent reauthorization to prevent it from expiring September 30, 2023. Reauthorization Act of 2023 extends the authorization of the original 2017 READ Act for an additional five years, continuing U.S. efforts to expand equitable access to quality education for children in foreign assistance. The READ Act ensures the U.S. government will continue to update and report on their strategy to improve foundational literacy and numeracy in basic education around the globe.
