Vol. 167: U.S. Senate Judiciary Committee, International Day of Education, & Thrive Coalition Event

January 29, 2024

Quick Summary

The U.S. Senate Committee on the Judiciary will hold a [hearing](#) on January 31, 2024 focusing on “Big Tech and the Online Child Sexual Exploitation Crisis.” The CEOs of Meta, X, Snap, TikTok, and Discord are set to testify for the first time and to respond to their alleged failures in protecting children online. The Senate Judiciary Committee has introduced bipartisan bills to address the surge in online sexual exploitation and abuse of children. The National Center for Missing & Exploited Children [reported](#) a doubling of child sexual abuse material (CSAM) reports in 2022, reaching over 32 million. A growing movement in the U.S., including organizations like the End Online Sexual Exploitation and Abuse against Children (OSEAC) Coalition and campaigns like ChildFund’s #TakeItDown, urges action against online child exploitation.

Currently tech companies are required to report CSAM. However, tech companies are not mandated to be proactive in their search for it, and standards for transparency and accountability are lacking. The hearing will focus on how these platforms fall short and have failed to ensure safety for children, with three CEOs subpoenaed for non-compliance. In a [blog post](#) by ChildFund, they emphasize the need for regulation and for passage of three bipartisan bills: the EARN-IT Act, REPORT-Act, and STOP CSAM Act. The organization urges Big Tech to go beyond legislation, advocating for comprehensive internal teams, technological solutions, annual transparency reports, and investment in survivor resources to create a safer online environment for children. The International Day of Education was January 24th and this year focused on the theme "learning for lasting peace". Currently, a quarter of humanity, approximately 2 billion people, reside in conflict-affected areas. To address this concern, activists are mobilizing support for the Reinforcing Education Accountability in Development (READ) Act ([H.R. 681](#) / [S.41](#)) and urging Congress to reauthorize this critical bill. The READ Reauthorization Task Force is calling for Congressional action to build upon the achievements of the original five-year strategy enacted in 2017, which significantly enhanced access and learning outcomes for inclusive, quality education for children and youth globally. The diverse expertise of these guest speakers, representing both regional and international perspectives, contributed to a comprehensive understanding of the complex relationship between climate change and early childhood development. The event facilitated an exchange of knowledge and ideas, fostering collaboration and awareness within the Thrive Coalition community.
