**Quick Summary** 

In anticipation of the upcoming European Parliament elections scheduled for June 2024, <u>ChildFund Alliance</u>, <u>EuroChild</u>, <u>Save the Children</u>, <u>SOS Children's</u> <u>Villages</u>, and <u>UNICEF</u>, in collaboration with the <u>Child and Youth Friendly</u> <u>Governance Project</u>, have recently published a comprehensive report titled "Our Rights. Our Future. The Europe We Want." This report stems from consultations conducted with children aged 10 to 18 across the European Union. It provides valuable insights into their primary concerns, including education, mental health, discrimination, safety, participation, and climate change. Particularly noteworthy is the significant worry expressed by children about ongoing global conflicts, with 43% expressing deep concern. The report contains other valuable insights and recommendations for prioritizing children's well-being for European leadership; Such as creating decision-making guides for schools and developing mechanisms that ensure youth participation in policy-making, among others. In a recent interview, Leonardo Garnier, former Special Advisor to the Secretary General of the United Nations for Transforming Education Summit (TES), shared insights into the global efforts to achieve Sustainable Development Goal 4 (SDG4) ensuring inclusive and equitable guality education and promoting lifelong learning opportunities for all by 2030. Reflecting on the TES held in 2022 at the UN, Garnier highlighted its role in addressing critical issues like equity, inclusion, and quality in education. However, in the interview he expressed concerns about the challenges in translating awareness and agreement into concrete actions, citing political barriers and inadequate investment in education as major obstacles. "In many countries, the necessary political agreement is not achieved to make the investments education needs to promote curricular transformations and teacher training... We talk about it and produce many documents but do not reach the actions that count; if the transformation does not reach the classroom it is not transformation..." said Garnier. With public spending on education declining, Garnier stressed the need for tangible results through global education reform to ensure that transformation initiatives effectively impact classrooms and address the learning crisis. ## President Joe Biden delivers a <u>Proclamation</u> on National Child Abuse Prevention Month.

The guide offers an extensive list of supportive resources that can help communities effectively address the root causes of child abuse and neglect. Furthermore, the <u>National Child Abuse</u> <u>Prevention Month Outreach Toolkit</u> provides insight and suggestions for engaging your local and online communities in supporting children, youth, and families. Whether through proclamations, social media, or other means, raising awareness about child abuse prevention empowers individuals to take action in prioritizing children.

While positive legislative and local steps have been made, National Child Abuse Prevention Month serves as a reminder of the continuous work needed to protect children and support survivors across the globe. It is time to renew our commitment to building safer communities and helping those impacted by abuse. Through collaborative efforts, we can create a society where every child grows up safe, supported, and surrounded by care, ensuring a brighter future for future generations.
